

Minnesota Millionaire Raffle MOA Event- Official Drawing Procedures
November 7, 2009 Mall of America, Bloomington

1. To enter one (1) of the drawings, a player must make a qualifying purchase of \$10 in Lottery tickets at the Minnesota State Lottery's Minnesota Millionaire Raffle event at the Mall of America on November 7, 2009 between 12:00 p.m. and 3:57 p.m. or at the Holiday Superstation Store at the Mall of America on November 7, 2009 between start of sales at the event (approximately 12:00 p.m.) and 3:30 p.m.
2. A player that makes a qualifying purchase (\$10.00 in Lottery tickets) will receive a two-part raffle ticket that contains a unique number. To enter the player must deposit one part of the raffle ticket into the official Minnesota State Lottery entry drawing box located in the Best Buy® Rotunda area at the Mall of America.
3. A player that makes a qualifying purchase at the Holiday Superstation Store at the Mall of America will receive a wooden nickel which can be redeemed for an official raffle ticket from the Lottery in the Best Buy® Rotunda area at the Mall of America. To enter the player must deposit one-part of the raffle ticket into the official Minnesota State Lottery entry drawing box located in the Best Buy® Rotunda area at the Mall of America.
4. A player may enter as many times as they wish. The official raffle ticket is the only acceptable form of entry. A facsimile or photocopy of the raffle ticket is not an eligible entry. Entries will be void if mutilated or illegible.
5. A winner must be 18 years of age or older and possess a valid ID.
6. There will be one (1) Grand Prize Drawing and fifteen (15) \$50 Shopping Spree Drawings. The \$50 Shopping Spree Drawings will occur every fifteen (15) minutes between 12:15 and 3:45 p.m. The Grand Prize Drawing will occur at approximately 4:00 p.m.
7. To be eligible for a \$50 Shopping Spree Drawing, an entry must be deposited in the official Lottery Drawing box at least one (1) minute prior to the Drawing. The drawing box used for each \$50 Shopping Spree Drawing will be emptied after each drawing. All entries submitted for a \$50 Shopping Spree Drawing will not be eligible for any subsequent \$50 Shopping Spree Drawing. All entries submitted for a \$50 Shopping Spree Drawing that have not been selected and all entries submitted after the deadline for the last \$50 Shopping Spree Drawing and prior to 4:00 p.m. are eligible for the Grand Prize Drawing.
8. Each entry selected in the fifteen (15) \$50 Shopping Spree Drawings will receive a \$50 Visa gift card. The one (1) entry selected in the Grand Prize Drawing will receive a \$2,000 Visa gift card.
9. Players may win more than once, but each official Lottery drawing entry may only win once (example: if a winner claims a \$50 Shopping Spree, another qualifying purchase will be required to re-enter for the \$2,000 Grand Prize drawing).

10. Employees (including immediate family residing in the same household) of the Minnesota State Lottery and any company that is not eligible to receive a prize from the Minnesota State Lottery under Minnesota law or pursuant to a contract with the Minnesota State Lottery are ineligible to participate or receive a prize from these drawings. Winners will be selected and eligibility determined by the Minnesota State Lottery officials. The decision is final, binding and conclusive in all matters.

11. Entries will be selected by Lottery Officials and announced and posted in the Best Buy® Rotunda area of the Mall of America. Winners MUST claim their prizes in person by 4:30 p.m. on November 7, 2009 in the Best Buy® Rotunda area of the Mall of America. To claim a prize for a \$50 Shopping Spree Drawing, the player must present the raffle ticket with the same number as drawn, a picture ID and execute an affidavit of eligibility. The player whose entry is selected in the Grand Prize Drawing must present the raffle ticket with the same number as drawn, a picture ID, execute an affidavit of eligibility, and complete a Lottery claim form. If a person does not claim their prize in person by 4:30 p.m. on November 7, 2009 in the Best Buy® Rotunda area of the Mall of America, the player forfeits all rights they may have to the prize.

12. By entering a drawing, a player consents to full use of their name, city, state and photo for publicity and public relations purposes, and must agree to videotape production for broadcast with no further compensation. The winner may be required to execute an affidavit of eligibility, appropriate releases and authorizations for such purposes and refusal to do so may result in forfeiture of any prize won.

13. Odds of winning will be determined by the total number of entries.

14. No cash equivalents will be awarded. The prize is not exchangeable or otherwise transferable. Federal, state or local taxes on any prizes are the sole responsibility of the winner. All applicable federal, state and local laws apply.

15. Following the drawing, all entries will be retained by Minnesota State Lottery for a period of 90 days.
