

Minnesota State Lottery
Speedway SuperAmerica Free Gas Giveaway
Official Promotion Drawing Rules

1. To enter, players must mail in one (1) \$5, \$10 or \$20 non-winning Minnesota State Lottery Scratch ticket purchased at any participating SuperAmerica store between October 1, 2008 and October 31, 2008. No facsimiles or photocopies accepted. Players may enter more than once.
2. Players must fill out the back of the Scratch ticket with their name, address, and phone number. Incomplete and unreadable entries will be disqualified.
3. The Scratch Ticket entry must be included in an envelope no larger than 10" x 5" and mailed to: "Free for a Year" Giveaway, Minnesota State Lottery, P.O. Box 131235, Roseville, MN 55113-0011. The ticket entry must be sent through First Class regular U.S. Mail. No drop-off or special delivery entries will be accepted. Entries must be received by 5:00 p.m. on Monday, November 3, 2008.
4. An entry will be considered invalid if the ticket was used as entry in any other Lottery promotion or second chance drawing.
5. Winning tickets or other correspondence may not be included in the entry envelope.
6. An entry will be considered invalid if it does not meet all of the requirements of these procedures.
7. Employees (including immediate family or household members) of the Minnesota State Lottery (MSL) and employees (including immediate family or household members) of SuperAmerica stores are ineligible to participate. Winners will be selected and eligibility determined by the MSL. The decision is final, binding and conclusive in all matters. Players must be 18 years or older to purchase lottery tickets or enter this drawing.
8. Only one (1) winner per household. An entry will be considered invalid if the person whose name appears on the ticket or a member of the immediate family of the person residing in the same household has been previously drawn.
9. Winning entries will be drawn at random for the following prizes from the MSL drawing box at Lottery Headquarters by a MSL representative on or about Tuesday, November 4, 2008. Prizes will be awarded in the order they are selected. Prizes are as follows: **FIRST PRIZE** - (1 awarded) \$4,800 in Free Gas (\$400 a month for a year) **SECOND PRIZE** - (4 awarded) \$500 Gas Card **THIRD PRIZE** - (6 awarded) \$100 Gas Card PLUS a Lottery prize pack to include one (1) Can Cooler on Wheels and one (1) Fleece Throw (\$90.00 approx. value).

10. If more than one (1) name appears on the ticket, the Lottery will randomly select one (1) of the names provided. Alternates will be drawn during the drawing. Winners are not official until validated by the Lottery. Scratch tickets drawn as winners will be verified by the Lottery as having been purchased at a participating SuperAmerica store.
11. The winner of the First Prize will be notified after their entry has been drawn and declared eligible. The winner of the First Prize must submit a Winners Claim Form provided to the winner by the Lottery. If the person does not present a completed claim form to the Lottery within the 30 days of being notified by the Lottery, the person forfeits all rights to the prize. If the claim is validated by the Lottery, the \$4,800 in Free Gas (12 gas cards - \$400 on each card) will be delivered to the winner. In the event the claim is not validated by the Lottery, the claim will be denied and the person will be notified immediately. The Second and Third Prize winners will be delivered to the winner's address.
12. The Lottery provides no warranties, guarantees or representations of any kind express or implied, arising by law or otherwise including, without any limitation, any implied warranty or fitness for a particular purpose or any implied warranty arising from course of performance, course of dealing or usage or trade in relation to merchandise prize won in this promotion.
13. By submitting an entry and the winners consent to full use of their name, address and photo for publicity and public relations purposes with no further compensation. Winners may be required to execute an affidavit of eligibility, appropriate releases and authorizations for such purposes and refusal to do so may result in forfeiture of any prize won.
14. Odds of winning will be determined by the total number of entries submitted.
15. No cash equivalents will be awarded. Prizes are not exchangeable or, otherwise, transferable. The MSL reserves the right to re-award any prizes, to substitute equivalent prizes and to correct errors in any contest or promotional materials. Federal, state or local taxes on any prizes are the sole responsibility of the winner. The Lottery will not be responsible or liable for any warranty or guarantee, either expressed or implied, on any prizes.
16. Following the drawing, all entries will be retained by the MSL for a period of 90 days following the drawing date.
17. This drawing may be terminated at any time and the promotion procedures may be amended upon agreement by the MSL. All applicable federal, state or local laws apply.
